Payment of Annual Dues

Annual dues will be payable, 50% on February 1, 2009 and the remaining 50% on April 1, 2009. Any Member not paying their annual dues by May 1, 2009, will have their name posted and all privileges will be suspended until payment is made in full. Membership dues can be paid by cash, cheque, debit, Visa or Mastercard.

Categories and Qualifications

- Shareholder** Includes clubhouse privileges for spouse and playing privileges for children under 19 as of April 1, 2009
- Young Executive** Available to those age 25 to 30 as of April 1, 2009.
- Intermediate** Available to those age 19 to 24 as of April 1, 2009.
- Sponsored Junior** Available to those age 12 to 18 as of April 1, 2009 who are sponsored by a Shareholder in good standing.
- Corporate** Upon payment of annual dues will be allowed to play 80 games during the season. Some restrictions apply. Not considered a shareholder.

Food & Beverage Assessment

Minimum purchases, made by October 19, 2009, in all categories except, Intermediates, Juniors and Clubhouse, are set as follows: Shareholder \$500.00, Spouse \$150.00, Young Executive \$265.00, Corporate \$975.00. Any amount short of the appropriate category will be charged at the end of October.

Payment for Purchases and Services

All charges are payable upon receipt of statement. Overdue accounts are subject to a service charge of 2% per month. Failure to pay within 45 days of statement will result in Member's names being posted and all privileges being suspended until payment is made.

Playing Times

Restricted Shareholders, Spouses, Young Executives, Intermediates and Juniors:

No tee times prior to 12noon on Saturdays, Sundays & Holidays.

No tee times between 2:30pm & 5:30pm, Tuesdays & Thursdays.

Corporate: Maximum 2 members per day, unrestricted tee time playing privileges, subject to existing guest restrictions, privileges and charges.

Membership Fees for Shareholders include access to the Driving Range, complimentary club cleaning, pull carts, shoeshine, locker and MGA / RCGA dues. Pine Ridge Golf Club is not responsible for lost items, personal injury or any damages to vehicles. All members are required to adhere to the policies and by-laws of the Club.
